

2010 ALLEN PARK ARTS AND CRAFTS STREET FAIR - RULES AND REGULATIONS

DATES AND HOURS:

FRIDAY, AUGUST 6, 2010 10:00AM - 9:00PM

SATURDAY, AUGUST 7, 2010 10:00AM - 9:00PM

ARTWORK:

All work must be of fine quality and original work of entrant. Such items as imports, velvet paintings, manufactured or kit jewelry, and any commercially (factory) produced merchandise are not eligible for exhibit or sale. We do not provide space to informational groups, non-profit organizations or businesses wishing to distribute literature or solicit business.

SALE OF SILLY STRING (OR SIMILAR ITEMS) IS STRICTLY PROHIBITED
NO RAFFLES ALLOWED - NO HAWKING OF MERCHANDISE

ENTRY:

All artists and craftspeople must submit **three (3) photos** (no slides) of each category of work to be exhibited. Each photo must be clearly labeled with artist's name and medium. If accepted, one photo will be kept by the Commission for future reference. The completed application form must accompany the pictures along with the required non-refundable \$5.00 jury fee. You must also include a stamped, self-addressed, size 10 (legal) envelope for return of photos. APPLICATIONS MUST BE POSTMARKED BY **February 26, 2010**.

SPACE ASSIGNMENT:

Set-up space is 10' x 10'. Artists must provide chairs, tables and other display equipment. You may not sell, divide or give space to another artist. Space may be shared if so requested when application is returned. **No electricity is available.** Items from your space must not extend beyond your allotted area and you may not move from your designated area. Booths must be kept neat and attractive at all times during the Fair. Overall quality will be judged during the Fair. If you must leave the Fair due to an emergency, please notify the Street Fair Commission. **DO NOT LEAVE DEBRIS ON THE STREET AT CLOSE OF FAIR.**

FEES:

Each entry must include the \$5.00 non-refundable Jury Fee made payable to the **ALLEN PARK FESTIVITIES COMMISSION**. Upon acceptance you will be notified to submit your booth fee by May 28, 2010. The booth fee for the 2010 Street Fair will be \$100.00 per space. Artists wishing to cancel may do so until July 1, 2010.

NO REFUNDS WILL BE ISSUED AFTER JULY 1, 2010.

PARTICIPANTS NOT IN COMPLIANCE WITH THE STATED RULES AND REGULATIONS WILL NOT BE ALLOWED TO PARTICIPATE IN THE FOLLOWING YEAR'S FAIR.
