Ordinance – 2005-11 – Dated January 24, 2006 – (Synopsis)

- A Block is defined as all properties between two intersections (both sides of street)
- A Block cannot include a major road
- 90% approval of Block is required
- Approval signature of property owner and their address
- Missing signatures constitute disapproval

Police & Fire Departments are allowed to object within 10 days of application
All objections/rejections may be appealed to Mayor and Council

BY SIGNING, YOU ARE AGREEING TO BE BOUND TO THE CONDITIONS CONTAINED WITHIN THIS DOCUMENT, ONCE THE CITY ACCEPTS IT. THIS IS A LEGAL DOCUMENT, WHICH GRANTS CERTAIN RIGHTS, RESPONSIBILITIES AND LIABILITIES. IF YOU ARE UNSURE OF ITS CONTENTS, PLEASE CONTACT YOUR ATTORNEY.

IN CONSIDERATION FOR THE CITY OF ALLEN PARK (CITY) GRANTING THE USE OF THE PUBLIC STREET TO HEREIN SIGNED HOMEOWNERS (ASSOCIATION) FOR A BLOCK PARTY THE FOLLOWING IS AGREED TO:

THE ASSOCIATION SHALL BE DEFINED TO INCLUDE ALL RESIDENTS ON THE STREET OF THE BLOCK PARTY AND ALL INDIVIDUALS PARTICIPATING IN THE PARTY.

THE CITY WILL ALLOW THE ASSOCIATION THE USE OF THE PUBLIC STREET FOR A BLOCK PARTY ON THE DATE AND HOURS SET FORTH ABOVE AND WILL PROVIDE (2) TWO NECESSARY **BARRICADES** FOR THE CLOSURE OF THE STREET UPON THE ASSOCIATION **CONTACTING THE DEPARTMENT OF PUBLIC SERVICE at 313-928-0550.**

THE ASSOCIATION HEREBY RELEASES AND SHALL INDEMNIFY AND HOLD HARMLESS THE CITY FOR ANY AND ALL LIABILITY FOR ANY CLAIM, LOSS OR DAMAGE TO EITHER PERSON OR PROPERTY RESULTING FROM THE USE OF THE PUBLIC STREET.

THE ASSOCIATION SHALL NOT ALLOW OR PROVIDE ALCOHOL OR INTOXICATING BEVERAGES TO ANY PERSON, UNDER TWENTY-ONE (21) YEARS OF AGE, ON SUCH STREET DURING THE PARTY.

THE ASSOCIATION SHALL NOT MAKE OR CREATE ANY LOUD NOISE OR MUSIC BEFORE 7:00AM OR AFTER 11:00PM.

THE ASSOCIATION SHALL NOTIFY THE CITY IN WRITING, WITHIN 30 DAYS, OF ANY CLAIM MADE OR FILED AGAINST THE ASSOCIATION, ANY RESIDENT OR INDIVIDUAL AS RESULT OF THE BLOCK PARTY.
