  2. Alterations and repair work determined by the plumbing official to be of a minor nature
  3. Buildings with a required plumbing fixture count less than 12
  4. Work done by a government subdivision or state agency costing less than \$15,000

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

### Applicant Signature

Section 23a of the state construction code act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subject to civil fines.

**Expiration of Permit:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A permit will be canceled when no inspections are requested and conducted within six months of the date of the issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.**
