 - a. Sports Program Updates-Hockey, Baseball, Bulldogs, COVID-19, Adult Softball, Senior Softball, Gym Use, etc. *Spring hockey moving forward with rink staying open extra week to accommodate, APAC starting, Bulldogs moving forward as DYFL is planning a season, Adult Softball starting with extra league, Senior Softball playing DH on Tuesday AM starting May 11, Limited use of gym due to Covid and users not following state guidelines.*
 - b. Hockey Tournament *Little Caesar's booked ice May 14-16 so we stayed open an extra week.*
 - c. Parking Lots *Rink parking lot approved for resurfacing. Cunningham on next agenda.*
 - d. DDA Events *After our success with Concerts in the Park, DDA is planning 8 concerts in the street, movie in the street, trivia tournaments weekly and KofC is planning 6 concerts. All using Showmobile.*
 - e. Flower Beds *P&R & DPS will handle initial planting of over 40 flower beds in the city. Still a work in progress.*
 - f. Senior Transportation Driver *Still looking for substitute and regular SMART Drivers.*
 - g. Last Minute *Roofs at Brand Storage Building, Champaign Restrooms and Riel Shelter were replaced with Napier Roofing as the Contractor.*

 - d. Showmobile *Showmobile will likely be used @25 times in 2021. Legal Affairs Committee is miffed on the purchase and wants inspection, repair costs, etc. prior to approving Shared Use Agreement with DDA and Streetfair.*
 - e. Cunningham Graffiti *Perpetrator caught on camera, after reluctance on restitution amount is now in the police-court system.*
 - f. Hall of Fame *Prior to Millward Concert. Info requesting applications has been put up on facebook.*
 - g. Kennedy Park *County is handling all aspects of bids, reviews, payments, etc. for grant.*
 - h. APCCF Beer & Wine Tasting *Currently holding an August date for event but not looking like it will happen.*
 - i. Summer Arena Use *We are allowing a summer concert group to rehearse in arena and receiving a discount for event.*
