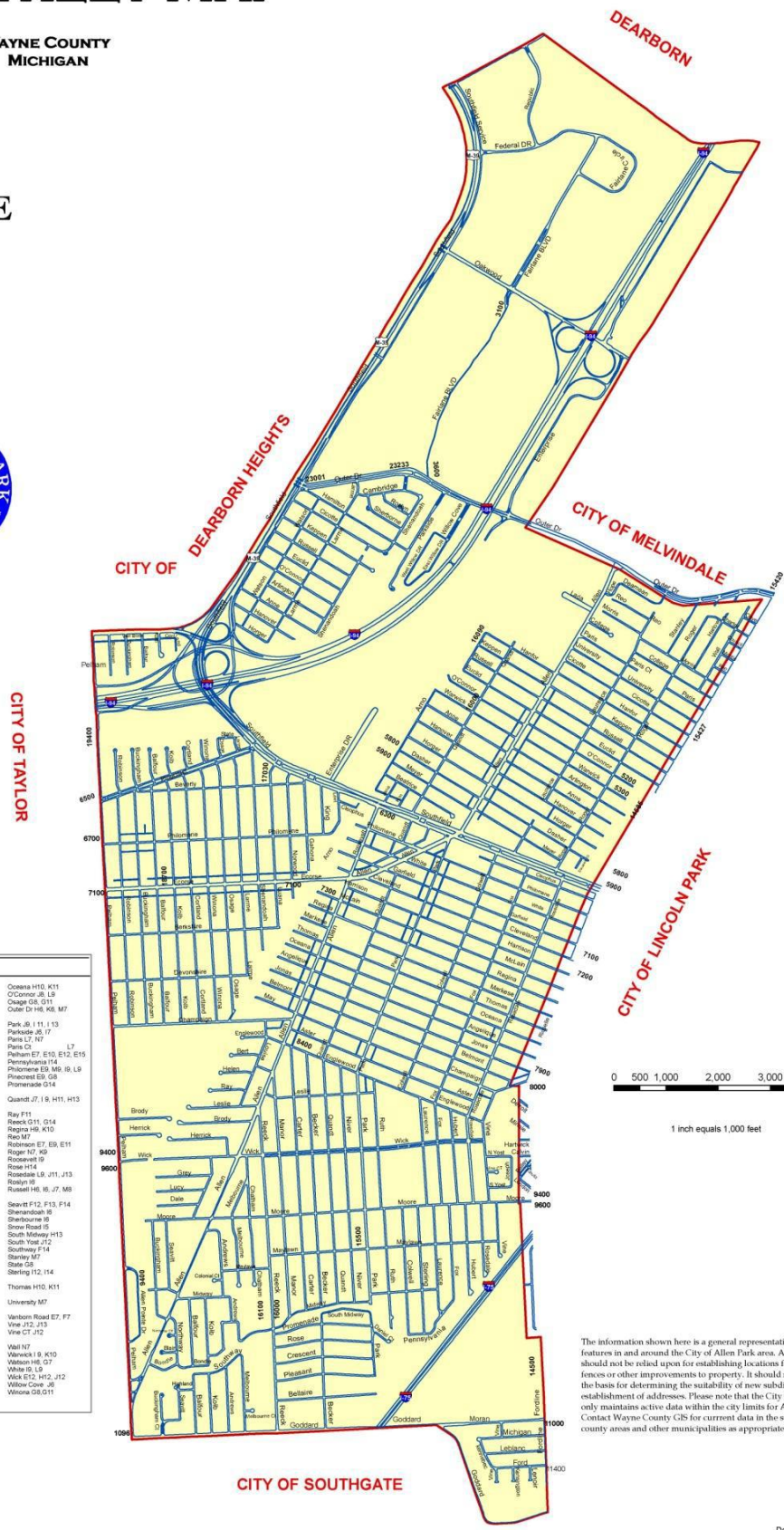

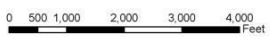
CITY OF ALLEN PARK STREET MAP
