ORDINANCE #05-2018

AN ORDINANCE OF THE CITY OF ALLEN PARK CODE OF ORDINANCES; AMENDING THE CODE OF ORDINANCES BY ADDING SECTION 12-2, “PROHIBITION OF MARIHUANA BUSINESSES AND ESTABLISHMENTS” TO ARTICLE I, “IN GENERAL”, OF CHAPTER 12, “BUSINESSES”, TO PROHIBIT MARIHUANA BUSINESSES AND ESTABLISHMENTS IN THE CITY PURSUANT TO THE MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT, BALLOT PROPOSAL 1 OF 2018.

The City of Allen Park Ordains:

SECTION 1. Amendment to Code.

That Section 12-2 “Prohibition of Marihuana Businesses and Establishments”, be added under Chapter 12 “Businesses”, Article I “In General”, to hereafter read as follows:

Chapter 12 “Businesses”
Article I “In General”

Section 12-2. – Prohibition of Marihuana Businesses and Establishments.

Pursuant to the Michigan Regulation and Taxation of Marihuana Act, Section 6.1, the City elects to opt out and prohibit marihuana businesses and establishments within its boundaries.

SECTION 2. Repeal. All ordinances or parts of ordinances in conflict herewith are repealed only to the extent necessary to give this ordinance full force and effect.

SECTION 3. Saving Clause.

Nothing in this Ordinance or in the code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquiring or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

SECTION 4. Severability.

Should any word, sentence, phrase or any portion of this Ordinance be deemed invalid by any court of competent jurisdiction or by any state agency having authority to do so for any reason whatsoever, such holdings shall be construed and limited to such work, sentence, phrase, or any

portion of the Ordinance deemed invalid and shall not be construed as affecting the validity of any of the remaining words, sentences, phrases or portions of this Ordinance.

SECTION 5. Publication.

The Clerk for the City of Allen Park shall cause this ordinance to be published in the manner required by law.

SECTION 6. Adoption.

This Ordinance is hereby declared to have been adopted by the City Council of the City of Allen Park, County of Wayne, State of Michigan, at a regular meeting, called and held on the 13th day of November, 2018.
